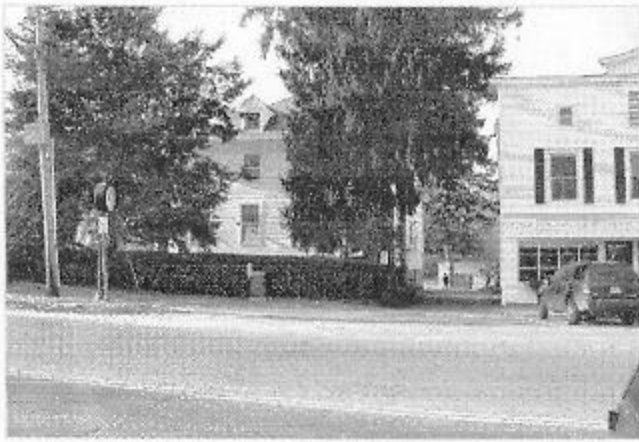

DRIVING DIRECTIONS TO NORTH HALL AT ST. STEPHEN'S CHURCH, RIDGEFIELD:

FROM NEW YORK:

I-684: Take Exit 6, Cross River. Go east on Rt. 35 to the fountain in Ridgefield, about 10 miles. Continue on Route 35 by turning left on Main Street. Go to the first stop light; the church is on your left. Just past the light, turn left into the alley between North Hall at St. Stephen's Church and Christman Stuart Interiors.

I-95 North: Take I-95 north to Exit 15, to Route 7 North, towards Wilton, Danbury and Ridgefield. Proceed on Rt. 7 through Norwalk and Wilton to where it intersects with Route 102 just north of the Wilton/Ridgefield line, and turn left, or west. Follow Route 102 up a long hill with many curves, until it dead-ends on Main Street in Ridgefield. Turn right on Main Street, which is also Rt. 35. Go to the first stop light; the church is on your left. Just past the light, turn left into the alley between North Hall at St. Stephen's Church and Christman Stuart Interiors.

Merritt Parkway (Rt. 15), Northeast: Take the Merritt Parkway northeast to Route 7 at Norwalk. Proceed north, towards Wilton, Danbury and Ridgefield on Route 7, through Wilton to where it intersects with Route 102 just north of the Wilton/Ridgefield line, and turn left, or west. Follow Route 102 up a long hill with many curves, until it dead-ends on Main Street in Ridgefield. Turn right on Main Street, which is also Rt. 35. Go to the first stop light; the church is on your left. Just past the light, turn left into the alley between North Hall at St. Stephen's Church and Christman Stuart Interiors.

FROM NEW HAVEN:

I-95 South: Take I-95 south to Exit 15, to Route 7 North, towards Wilton, Danbury and Ridgefield. Proceed on Rt. 7 through Norwalk and Wilton to where it intersects with Route 102 just north of the Wilton/Ridgefield line, and turn left, or west. Follow Route 102 up a long hill with many curves, until it dead-ends on Main Street in Ridgefield. Turn right on Main Street, which is also Rt. 35. Go to the first stop light; the church is on your left. Just past the light, turn left into the alley between North Hall at St. Stephen's Church and Christman Stuart Interiors.

Merritt Parkway (Rt. 15), Southeast: Take the Merritt Parkway southeast to Exit 42, for Route 57 at Westport. Take Route 57 north, 8 miles, until it intersects Route 7 in Georgetown. (There are two dogleg turns on Rt 57, at the mid-point and end; just follow the route signs). Turn right on Route 7 north; proceed through Branchville to the stop light at the intersection with Route 102, and turn left, or west. Follow Route 102 up a long hill with many curves, until it dead-ends on Main Street in Ridgefield. Turn right on Main Street, which is also Rt. 35. Go to the first stop light; the church is on your left. Just past the light, turn left into the alley between North Hall at St. Stephen's Church and Christman Stuart Interiors.

FROM POINTS NORTH:

From I-84 (East or West): Take Exit 3, marked as Rt. 7 south, towards Norwalk. Go about 3 to 4 miles on Rt. 7. At the first light, turn right onto Route 35 south, towards Ridgefield. Go through four traffic lights, and bear left at a blinking light. Proceed through two more traffic lights, along Ridgefield's Main Street. You will see diagonal parking on your right in front of a series of local stores: Hardware, jeweler, etc. At the end of this row is the Christmas Stuart Interiors; turn right into the alley beyond this store, which is next to North Hall at St. Stephen Church.
