



From the Desk of the Connecticut SAR State Registrar

November 1, 2018

To all those who are thinking about, or who are sending applications in for my review and approval, there are a few things that I've noticed that need to be addressed which will make it easier and faster for me to verify the applications and get them sent to National for approval in a timely manner.

1. As of November 1st, only the application form dated Rev Mar. 2017 Form #0915, will be acceptable for processing. All others will be returned to the submitted.
2. When you send in the application, PLEASE also send in the electronic version of the application. Often they are sent to me on 8 ½ by 11 sheets of paper and they need to be sent in on Legal size special watermarked paper. By not sending me the electronic versions of the applications I need to re-type the entire application and print it out on the correct size. Also, it's easier for me to correct errors or add additional references on the application.
3. When you send in copies of Census Records, I need to have the ACTUAL Census Record and it must be the ENTIRE Page, not just the section of where the family you are citing is listed. Also, they must be legible. If you are having trouble printing out the entire page, please contact me and I can tell you how to do it.
4. The SAR applications that are located on Ancestry.com are NOT acceptable as proof of lineage. Many of them were done at the turn of the century and genealogical standards are considerable stricter now than they were back then. If you are citing a DAR or SAR application for a more recent date, you need to make sure that any missing information or recent deaths, marriages, etc. are updated. Also, when using a DAR application Record Copy, it is NOT ACCEPTABLE if that application cites another application as its reference. You will need to go back to the original cited application to where it lists the documents that were used for approval.
5. Genealogies that do not list sources, particularly the ones written before 1980 cannot be used by themselves as a reference. If you are using a cited genealogy as reference I must have the entire page as well as the TITLE PAGE of the Genealogy. The same goes for County Histories, Etc.

There are other issues, but these are the biggies. I am ALWAYS available at any time if you have questions or are not sure which documents are acceptable. With your help, I can verify and send in all applications in a timely manner.
